

**TAX CREDIT SCHOLARSHIPS  
TO BENEFIT AWAKENING SEED SCHOOL STUDENTS**

Please reduce your state tax liability by helping educate a child at the Awakening Seed School. Arizona tax law allows any Arizona taxpayer to CLAIM A DOLLAR-FOR-DOLLAR TAX CREDIT of up to \$500 per individual and \$1,000 per couple for making a voluntary contribution to the Schools with Heart Foundation. Your \$\$\$ to state government or a child's education! **The amount due for your Arizona taxes will be reduced by the total amount you contribute to Schools with Heart Foundation.** Donors may not restrict their tax credit to a specific student. All scholarships are awarded on a need basis (K thru 4<sup>th</sup> Grade). Please mail your contribution today (USPS dated no later than December 31<sup>st</sup>), or drop it off in the Seed office before December 16<sup>th</sup> and we will mail it for you.

IF YOUR EMPLOYER SUBTRACTED \$1,000 OUT OF YOUR PAY CHECKS <b>(\$1,000)</b>	AND YOU MADE A PRIVATE SCHOOL TAX DONATION \$1,000	AND YOU OWE <b>\$1,000</b> ON YOUR ARIZONA TAX RETURN INSTEAD OF GETTING A \$0 REFUND <b>YOU WILL GET A \$1,000 REFUND</b>
IF YOUR EMPLOYER SUBTRACTED \$1,000 OUT OF YOUR PAY CHECKS <b>(\$1,000)</b>	AND YOU MADE A PRIVATE SCHOOL TAX DONATION \$500	AND YOU OWE <b>\$1,000</b> ON YOUR ARIZONA TAX RETURN INSTEAD OF GETTING A \$0 REFUND <b>YOU WILL GET A \$500 REFUND</b>
IF YOUR EMPLOYER SUBTRACTED \$1,500 OUT OF YOUR PAY CHECKS <b>\$1,500</b>	AND YOU MADE A PRIVATE SCHOOL TAX DONATION \$1,000	AND YOU OWE <b>\$1,200</b> ON YOUR ARIZONA TAX RETURN INSTEAD OF GETTING A \$300 REFUND <b>YOU WILL GET A \$800 REFUND</b>
IF YOUR EMPLOYER SUBTRACTED \$1,400 OUT OF YOUR PAY CHECKS <b>\$1,400</b>	AND YOU MADE A PRIVATE SCHOOL TAX DONATION \$1,000	AND YOU OWE <b>\$2,400</b> ON YOUR ARIZONA TAX RETURN INSTEAD OF OWING <b>\$1,000</b> <b>YOU WILL OWE \$0</b>
